The City has not kept up with the desktop and laptop computer

replacements due to the down turn in the economy. The newest machine the City is running is 8 years old and we are seeing a large failure rate of our current machines. During the budget cycle, staff proposed replacing the computers along with a network infrastructure upgrade. The City received 4 bids for the computer replacement, only one of them met the specifications.
