Background/Alternatives:

The current Parks and Recreation Master Plan, adopted by ordinance, is for the period of 2008-2018. With the period of the plan expiring this year, the Parks and Recreation Department would like to prepare a new plan to provide guidance over the next 5 years from the date of its adoption. Laura Leigh, Director of Community Development, has agreed to act as the facilitator for the plan's preparation over the next calendar year saving thousands of dollars in consultant fees. The process involves engaging the community and developing a committee to develop goals and objectives based on the feedback from community members and key stakeholders. We are requesting the Mayor appoint one member of the governing body to serve on the planning committee. The purpose of this resolution is to seek the governing body's support in preparing the Parks and Recreation Master Plan.
