

CITY OF GREEN RIVER – COMMUNITY DEVELOPMENT DEPARTMENT

Before doing business in the City of Green River, a business license must be applied for and approved by the Community Development Department.

Procedures for obtaining a license are as follows:

- ◆ Obtain and complete the business license application and/or home occupation form (if applicable) available in the Community Development Department at City Hall.
- ◆ The Community Development Department must review and approve the completed application.
- ◆ Fees must be paid.

General guidelines for conducting business in Green River:

- ◆ Restaurants or businesses where handling of food is required must also submit a letter from the State Health Inspector indicating their approval.
- ◆ Home Occupations – a home occupation is a gainful occupation or profession, whether conducted on-site or off-site, which is clearly incidental and secondary to the use of the dwelling for dwelling purposes and does not change the residential character thereof. For more information on home occupations please review the Home Occupation Permit Application.

Traveling Merchants:	
For 0 – 30 days	\$ 10.00
For more than 30 but less than 364 days	\$ 25.00
(for each month or part thereof)	
For one year or more	\$100.00

*Fees are charged one-half the annual rate during October 1st to January 31st. The licenses are renewed on April 1st of each year. An Occupation Tax (Business License) Renewal Notice is mailed to each business in February.
