- **Scoring/Competing:** Each participant is allowed one punt, one pass, and one kick. Scores are based on both distance and accuracy. Final score is cumulative total for the three individual events.
- **Ages:** 6/7 (2010 & 2009) 8/9 (2008 & 2007), 10/11 (2006 & 2005), 12/13 (2004 & 2003), 14/15 (2002 & 2001)

- First place winners in each age group/gender will advance to the Sectional Competition in Riverton, WY. This event will take place October 16<sup>th</sup>, beginning at 1:00 pm. Check in is at 12:30.

### **PPK Entry Form and Release of Liability**
