## CONTRACT FOR SERVICES

THIS AGREEMENT entered into this 20th day of August, 2019, by and between the City of Green River, Sweetwater County, Wyoming, a Municipal Corporation, hereinafter "City", and the Golden Hour Senior Center, hereinafter "Senior Center."

WHEREAS, the Senior Center administers the congregate meals program, the home delivered meals program and socialization services for senior citizens in Green River; and

WHEREAS, the congregate and home delivered meals programs provides meals to individuals that could not afford or be able to cook their own meal; and

WHEREAS, the congregate meals program, the home delivered meals program, and socialization programs are important programs to the community; and

WHEREAS, it is deemed important by the Governing Body of the City of Green River to support the Senior Center in their efforts to provide these programs; and

NOW, THEREFORE, IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS:

In consideration of the mutual covenants hereinafter set forth, the parties agree:

1. The City shall pay Senior Center the sum of \$22,000 for the fiscal year beginning July 1, 2019, and ending June 30, 2020.
2. The Senior Center shall budget, appropriate, and expend said sum for the sole purpose of providing low-income assistance, food and supply costs for congregate and home-delivered meals to citizens of Green River, and supply costs for building maintenance and improvement.
3. This agreement contains the entire understanding of the parties. The parties stipulate that neither of them has made any representation with respect to the subject matter of this agreement or any presentations including the execution and delivery hereof except such representations as are specifically set for the herein and each of the parties hereto acknowledges that it has relied on its own judgment in entering into this agreement.
4. No waiver or modification of this agreement or of any covenant, condition, or limitation herein contained shall be valid unless in writing and duly executed by the parties to be charged therewith and no evidence of any waiver or modification shall be offered or received in evidence of any proceeding, arbitration, or litigation between the parties hereto arising out of or affecting this agreement, or

the rights or obligations of the parties hereunder, unless such waiver or modification is in writing, duly executed as aforesaid, and the parties further agree that the provisions of this section may not be waived except as herein set forth.

5. All agreements and covenants contained herein are severable, and in the event any of them shall be held to be invalid by any competent court, this contract shall be interpreted as if such invalid agreements or covenants were not contained herein.
