WHEREAS, the Governing Body desires to support the National Night Out program, **and**

WHEREAS, the Governing Body desires to accept a restricted donation from TATA Chemicals for the promotion of National Night Out and for the purchase of door prizes for the event, **and**

WHEREAS, the Governing Body desires to increase the expenditure budget authority in the General Fund the Records Division (10.200.240.INPBRL.60) in the amount of \$1,000 to allow for the restrictions above; **and**

WHEREAS, the Governing Body desires to increase the General Fund Grants revenue for the purpose of funding the project in the amount of \$1,000;

NOW, THEREFORE, BE IT RESOLVED, THAT THE GOVERNING BODY ACCEPTS A RESTRICTED DONATION FROM TATA CHEMICALS IN THE AMOUNT OF \$1,000 AND APPROVES AN INCREASE IN THE GENERAL FUND RECORDS BUDGET IN THE AMOUNT OF \$1,000 AND AUTHORIZES THE CITY ADMINISTRATOR AND CITY TREASURER TO MAKE THE ABOVE CHANGES TO THE CITY BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2023.
